GENERAL INFORMATION

The Oneita J. Waltenberger Scholarship Trust provides scholarship grants for students who reside or have previously resided in DeKalb County for college and postgraduate studies for careers related to the health care field, including, but not limited to, physicians, nurses, certified nursing assistants, physical therapists, massage therapists, acupuncturist, health care administrators, dentist, or dental assistants. These funds have been provided by the trust estate of Oneita J. Waltenberger, a DeKalb County resident. Ms. Waltenberger wished to provide a general scholarship fund to students who exhibited good character, work habits, and perseverance in their pursuit of a health care field. These scholarship funds are administered by First Midwest Bank, a northern Illinois based bank with many branches in DeKalb County.

WHO IS ELIGIBLE?

To be eligible for an Oneita J. Waltenberger scholarship, you must reside or have previously resided in DeKalb County, you must (at the time of the award) be enrolled as a college or post-graduate student in good standing at an accredited institution (high school students are not eligible). All candidates who will be enrolled in a health care related program during the upcoming academic year are eligible to apply. The grants will be awarded without regard to financial need, but the total amount awarded may not exceed 50% of the total amount of tuition and fees for the academic period for which the award is received. All qualified applications will be given serious consideration. In order to qualify, please follow all directions on page 2 under “How Can I Apply?”

WHAT ARE THE CRITERIA FOR AWARDS?

Each applicant will be evaluated on an individual basis as a matter of judgment by the Oneita J. Waltenberger Scholarship Trust Committee. The Committee will base its judgment on the information submitted by the applicant who shall include three Letters of Recommendation from people familiar with the applicant who can provide insight as to the **applicant’s (1) character, (2) work habits, and (3) perseverance in pursuit of studies. THREE SEPARATE LETTERS MUST BE PROVIDED FOR EACH OF THESE AREAS AND EACH MUST BE SPECIFIC TO ONE OF THESE AREAS.** Use the form (or copies of this form) attached to this application for all letters of recommendation.

HOW CAN I APPLY?

- Applications are to be submitted for one academic year only. A student who has received a previous Oneita J. Waltenberger scholarship must submit a renewal application for each succeeding year.
- The Application must be typed in the pdf writeable form and printed out. **Do not leave any items unanswered.** If a particular item does not apply to you, write N/A in the blank.
- If insufficient space is provided for an item, use a blank sheet of paper as a supplement, identifying each response by the section and item number.
- Make sure to include your name on each and every page of the application.
- Obtain the certification of the Dean's Office (Section IV of the application). You must include an official academic transcript with the application which reflects GPA.
- Obtain one letter of recommendation from a person familiar with your **character**. (i.e., coach, club sponsor, clergy or youth minister). Use the form in Section V of the application.
- Obtain one letter of recommendation from a person qualified to assess your **work habits** (i.e., an employer or former employer). Use the form in Section VI of the application.
- Obtain one letter of recommendation from a person qualified to assess your **perseverance in the pursuit of your studies**. (i.e., former or present teachers). Use the form in Section VII of the application.
- Applications and **ALL** required documentation must be submitted in person and/or postmarked **no later than April 1st** prior to the academic year for which aid is being requested.

PLEASE BE MINDFUL THAT YOUR ABILITY TO CAREFULLY AND ACCURATELY COMPLETE THIS APPLICATION WILL BE CONSIDERED ALONG WITH YOUR QUALIFICATIONS BY THE COMMITTEE IN DETERMINING AN AWARD.
